### Conservation Assessment of Brazilian tree species towards the **Global Tree Assessment**

#### 1. Project goal

To produce increase the conservation assessment of Brazilian tree species contributing to the Global Tree Assessments – with the aim of conservation assessments of all tree species by 2020.

#### 2. Background

Brazil is the country worldwide that has the highest number of tree species.

The Global Tree Assessment aims to assess the conservation status of every known tree species by the year 2020. Two-thirds of all the world's trees are still lacking an assessment of extinction risk. The Global Tree Assessment will provide prioritization information to inform conservation action for trees, so that no tree species becomes extinct.

Red List assessments are proving very important in policy making and priority setting. Without species specific conservation assessment information, tree species are at risk of being neglected in conservation planning. To ensure functioning ecosystems and that conservation action is carried out for the species in most urgent need, an assessment of extinction risk across all tree species needs to be carried out.

The activities for this project are:

- a. Complete 1000 global IUCN Red List assessments of Brazilian tree species (using IUCN Categories and Criteria version 3.1, including a distribution map).
  - i. The reassessment of 100 species already published in National Red Book (2013 by CNCFlora/JBRJ), but these assessments are not on the Red List IUCN.
  - ii. Full global IUCN Red List assessments of 900 new tree species.
  - iii. The tree species to be assessed will be focused on Brazilian endemic trees, not endemic trees and included on Flora do Brasil and BGCl's GlobalTreeSearch database.
  - iv. Assessments need to be submitted (via BGCI) to IUCN via SIS or SISConnect
  - v. Distribution maps need to be delivered in csv file format (as specified by IUCN Red List mapping standards).

The final report will be released as soon as all activities are concluded. It will be sent through email, in PDF format.
