CONTRACTOR: As of Tuesday, March 12<sup>th</sup>, 2019, all of the aforementioned responsibilities shall be assumed by AMINO QUÍMICA LTDA., and the CONTRACTOR shall hold UNDP harmless.

The following is a list of complete activities carried out under the Conversion to non-HCFC Technology in the Manufacture of Polyurethane Foam of 32 pre-selected PU Foam end-users and the enterprise AMINO QUÍMICA LTDA. from August 2015 to July 2018:

System house's conversion: The conversion process of system house encompassed the following activities:

- Investment/ engineering project implemented at the polyurethane system production:
  - Plant adjustments (electrical grounding, piping and civil works);
  - Adaptation of storage area for flammable products (Methyl Formate and Methylal) and transfer system to mixing area;
  - Installation of nitrogen system linked to mixing units (system inertisation);
  - Installation of safety systems /sensors /alarms /fire extinguisher /exhaust system;
  - Retrofit of pre-mixer units used for production of FMF/ISF foams systems (sealing of tanks caps and explosion proof pump);
  - Retrofit of pre-mixer units used for production of polyurethane rigid foams systems (sealing of tanks caps and explosion proof pump);
  - Issuance of safety certificate;
  - Staff training on safety measures and on handling and storage of flammable substances.
